However, Broker will continue efforts to procure a purchaser of property and the Listing Agreement is agreed to be in full force and effect. Seller acknowledges that until the expiration or earlier termination of the Listing Agreement, Broker has the exclusive right to sell or exchange the property and Seller shall not, directly or indirectly, offer the property for sale or exchange, other than through Broker. Seller acknowledges that if the property is sold to, or exchanged with, any person or firm in violation of the Listing Agreement (whether or not such person or firm has been in contact with and whether or not Seller must pay another licensed real estate broker pursuant to a listing agreement), Seller shall pay to Broker the fee set forth in the Listing Authorization.
